## **General Burning Regulations**

On October 1, 2012, the State of Utah adopted Rule R307-202 establishing new burnings rules for communities such as ours. Weber Fire District will no longer issue burn permits. Burn permits are now issued online by the Utah Division of Air Quality: http://www.airquality.utah.gov/Compliance/OpenBurning/index.htm.

Burning for yard clean-up can only be done with a burn permit during the open burn window when the National Weather Service clearing index is 500 or greater. No vehicle, trash, rubbish, tires, hazardous material, or petroleum products are to be burned.

Certain agricultural and horticulture burning is exempt. Therefore, certain agricultural burning does not require a burn permit. However, notification prior to burning is encouraged by calling Weber Fire District at 801-782-3580.

The burn window has been is expanded under the new rule. Burn permits may be obtained in the spring between March 30 and May 30. Also, burn permits may now be available in the fall between September 15 and October 30 when approved by the state forester. You cannot obtain a burn permit from the state until the burn window begins.
