Weber Basin Water Conservancy

The Weber Basin Water Conservancy District (Weber Baisn) recently met with local leaders from northern Utah. Water resources are limited in Utah which is the second driest state in America. Weber Basin asked the city to inform residents about water conservation. Being aware of water consumption will reduce overall consumption rate. Many people use more water then needed.

Watch your household water use and observe where conservation can be made. When watering your lawn and garden on the city's pressurized system, adjust your watering schedule to evenings and night when possible. Adjust outdoor water schedules to match seasonal or weather conditions.
