## **General Burning Regulations**

The State of Utah now handles the issuance of burn permits. Weber Fire District will no longer issue burn permits. Burn permits can be obtained from the Utah Department of Environmental Quality:

Burning for yard clean-up can only be done with a burn permit during the open burn window when the National Weather Service clearing index is 500 or greater. No vehicle, trash, rubbish, tires, hazardous material, or petroleum products are to be burned.

The Spring burn permit window is between March 30 and May 30. The fall burn permit period is September 15 and October 30 when approved by the state forester. You cannot obtain a burn permit from the state until the burn window begins. Call the Utah Division of Air Quality at 801-536-4000 for more information.
