Weber Basin Water

The city's secondary water district and all irrigation companies have been informed that Weber Basin Water Conservancy District will turn off all irrigation water on October 1st rather than October 15th this year as a conservation measure. The city will leave on its secondary water system for residents for a few days longer until our water supplies are exhausted. Please prepare now for irrigation to end the first week in October.
