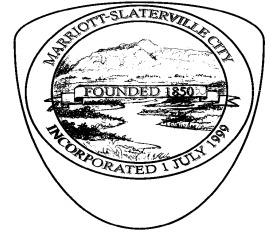

## Fee Increases

Central Weber Sewer Improvement District is proposing a fee increase to \$24.48 for residents inside the district, and \$75.00 for residents outside the district. Also, garbage rates will increase by .25¢ to cover inflation. A new monthly fire hydrant fee of .50¢ for residential and \$1 for commercial will be added to the water bill for fire hydrant installation and maintenance. The lack of fire hydrants in Marriott-Slaterville is causing problems for some residents with homeowners insurance, and creates a fire hazard. These fees commence January 1, 2017.
