City Council Report

Marriott-Slaterville City has two separate but equal branches of government. The Mayor leads the executive branch. The legislative branch is governed by the City Council. The executive branch handles daily functions of the City like municipal services, finances, complaints, roads, parks, planning, and other services. The legislative branch passes ordinances, sets policy, adopts the annual budget, approves contracts, confirms appointments, and exercises oversight. Two members of the City Council are elected from the east district, and two from the west district. One Council member is elected at-large. City elections are in odd numbered years.
