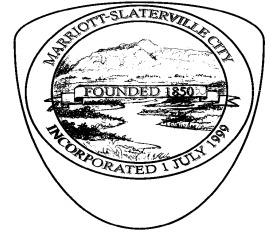

## Landlord Business License

Since 2013, the owner of any residential rental property is required to obtain a business license. If you are renting residential property to another you may require a business license. If you have not obtained a business license for your rental property you are to submit a application on or before December 31, 2015.

There has been an increase in criminal activity at residential rental properties in the city. All criminal activity is tracked by address and maintained by the Weber County Sheriff. The business license fee is based upon the calls for service for law enforcement provided to you and averaged with other similarly situated residential rental units.
