I, _____, understand that the issuance of this permit commits me to follow all of the requirements of Marriott-Slaterville Municipal Code, 15.24.040 and that I will be subject to any and all penalties associated with the violations of this Permit and /or applicable Ordinance. I understand that this Permit and associated SWPPP is required and will remain in effect until the entire project is stabilized, revegetated, and complete. The site and BMPs will be inspected on a regular basis to ensure compliance with this Permit and SWPPP. The permittee is responsible for permit and SWPPP compliance for the entire site and for the duration of the work and/or construction activity. The permittee is responsible for the actions of the subcontractors, vendors, delivery personnel, and others who will be working on the site. The permittee is responsible for any material that leaves the site, regardless of compliance with the SWPPP.

I hereby acknowledge that I have read the instructions and provisions of the Permit and applicable City Ordinances and agree to follow the terms and conditions of this Permit, the SWPPP, and applicable ordinances, rules, and regulations. I certify that this document and all attachments were prepared under the direction or supervision of those who have placed their signature below and in accordance with a system designed to assure that the information submitted was properly gathered and evaluated by qualified personnel or consultants. Based on my inquiry of the person or persons directly responsible for gathering the information, the information submitted is, to the best of my knowledge and belief, true, accurate, and complete.

Separate documentation shall be provided regarding such authorization.

Nothing contained in this packet is intended to relieve any person or entity from any obligation to comply with applicable federal and state laws and regulations pertaining to clean water and/or storm water runoff.
