E-cigarettes and Youth

The Weber-Morgan Health Department wants you to be aware of the risks of E-cigarettes. These devices are sometimes called “e-cigs,” “vapes,” “e-hookahs,” “vape pens,” and “electronic nicotine delivery systems (ENDS).” Some e-cigarettes look like regular cigarettes, cigars, or pipes. Some look like USB flash drives, pens, and other everyday items.

E-cigarettes are now the most commonly used tobacco product among U.S. youth. E-cigarette aerosol is not harmless “water vapor.” Most e-cigarettes contain nicotine, which is highly addictive. Nicotine exposure during adolescence can harm brain development, impact learning, memory and attention, and increase risk for future addiction to other drugs. E-cigarette aerosol can also contain harmful substances, including: cancer-causing chemicals, flavorings linked to lung disease, and heavy metals such as nickel, tin, and lead.
