JUNE 2022 – DROUGHT RESTRICTIONS

Some residents received post cards from Ogden City regarding their drought restrictions. Please disregard this information. Ogden City rules do not apply in Marriott-Slaterville City. Ogden City uses its drinking water for irrigation in many parts of that city. Marriott-Slaterville City has a much better planned irrigation system superior to Ogden.

Marriott-Slaterville City is part of Bona Vista Water Improvement District which does not use drinking water for irrigation, except for some businesses and other special circumstances. Marriott-Slaterville City has also secured irrigation water in case of drought periods as we are now experiencing. Many parts of Marriott-Slaterville City irrigate using flood irrigation provided by irrigation companies. If you are flood irrigating using water from a ditch company, follow the drought restrictions from the Board of Directors of that irrigation company.

Please be considerate that some people are watering differently than you are because they are under a different irrigation company or using the City's pressurized irrigation system. There are six (6) different irrigations companies in the City. Each irrigation company has different rules. Eventually, the irrigation companies will become subsumed by the City as part of the future development. However, at this time each company is separate and distinct. Do not be surprised to see residents who are flood irrigating, irrigating during the day. It is also common to see residents accessing and cleaning along ditches and head gates. Be considerate and understanding when reporting what you think may be a water violation because often it is not as people use the various irrigation systems in the community.

If you are serviced by the City's secondary water district, the drought restrictions will be implemented by the City. Over the summer, the drought restrictions may be changed to handle the drought situation as it evolves. For June 2022, the following drought restrictions apply:

1. Water on "even days" for "even addresses" and "odd days" for "odd addresses." This should result in a maximum watering of three (3) days per week. This means that Marriott-Slaterville City residents may be watering more than residents in some other cities. That is the benefit of living in a community that has planned and developed its water resources for this situation.
2. Limit pop-up sprays to twenty (20) minutes. Limit rotors to forty (40) minutes. This is just good irrigating practice and lets the roots of plants and trees take hold.
3. No residential irrigation between 10:00 am and 6:00 pm. This only applies to those watering on the City's pressurized irrigation system. This limits watering during the hottest part of the day.
4. Where possible, delay new landscape installation. For new construction you can ask the City for a landscape extension until next season.
5. Maintain and adjust watering systems and run time based on weather so there is no watering occurring during or after a rain storm. This prevents waste.
