# **Weber County Sheriff**

Marriott-Slaterville City has renewed a five (5) year contract with the Weber County Sheriff to provide law enforcement. Of the fifteen (15) cities in Weber County, eight (8) contract with the Weber County Sheriff for law enforcement. The new contract contemplates additional deputies and inflationary costs.

As the county has experienced unprecedented growth in recent years there is a need for additional deputies to cover the area. The contract cost is calculated based upon: 1) population, and 2) calls for law enforcement service. Currently, the City is annually paying \$356,000 for law enforcement, which will increase to \$397,000 under the new contract. There will also be annual increases depending on the need for additional law enforcement and as a result of inflation.

Our adjoining communities to the north, south, and west all contract with the Weber County Sheriff. Contracting with the Weber County Sheriff allows the community to substantially save taxes compared to those cities with their own police. It also allows the City to coordinate law enforcement across jurisdictions and to implement better community policies practices. If you would like to participate in community policing, please sign up for the Volunteers in Policing (VIPS) Program.

## **Business License Update**

Every five (5) years the City updates its business license regulations to further streamline the license process and to recalculate the Business License Fees. The City retained Zion's Bank Public Finance to conduct a Business License Fee Analysis to account for the costs related to each category of business.

A base fee will be determined along with a disproportionate fee for each business category. The disproportionate fee is based on calls for law enforcement service and transportation costs attributed to businesses with semi-truck traffic. The City intends to recover disproportionate costs as part of the Business License Fee. Anticipate now potential license fee increases to start next year.
