Winter Rules for the Road

As winter arrives in Marriott-Slaterville it is time to remember some rules for the road. No parking on any

roads between midnight and 7:00 AM from December 1 and March 1, during a snowstorm, and 72-hours after a snowstorm. This is so the snow plows can operate. Violators will be towed. The most traveled roads are plowed first. Subdivisions and lesser traveled roads are plowed last. Property owners with sidewalks are responsible to remove snow from the sidewalk within 24-hours after a snowstorm.

- **Property Taxes.** Marriott-Slaterville City does not levy a property tax. For property tax questions contact Weber County.
- **Election.** Only registered voters in the Marriott-Slaterville City West District will receive a ballot in the mail. If you do not receive a ballot call Weber County Election: 801-399-8034. Election Day is on Tuesday, November 21st.
