Spring Clean-up

Spring clean-up time is here. For your convenience, dumpsters will be placed at Marriott Park and Slaterville Park from **April 19-20**. Please put all debris inside the dumpster, not on the ground. This is a complimentary service. Please be considerate of others using the dumpster. No tires or hazardous material allowed. To dispose of junk cars, call the City Office at 801-627-1919.

Spring Flooding

The City does not anticipate flooding this year. However, the spring run-off may present surprises. The City and County will be monitoring the water levels of the Ogden River, Weber River, Mill Creek, Four Mile Creek and Six Mile Creek. Please take precautions in the event of flooding. Also, basements and crawl spaces are affected by high ground water levels in our area. Those living near the flood plain, rivers, streams, and waterways may be impacted. Secondary Water

Irrigation companies in the City will soon be turning on secondary water. Each irrigation company operates independently and had its own schedule to turn on irrigation water. The City will turn on its pressurized

irrigation system once the irrigation company provides the City with water. The City anticipates all systems will be on by May 1, 2024. There may be some delays as irrigation companies work on cleaning and piping sections of their ditch. There are no drought restrictions this year.

Local Updates

- ▶ **Burn Permits.** Weber Fire District reminds residents that the Open Burn window for yard clean-up is March 30 to May 30. For a burn permit visit: air.utah.gov/OpenBurning/form/. Burn permits are issued by the Utah Department of Environmental Quality.
- ▶ **Lock it up!** Spring and summer bring a spike in burglaries and thefts. The Weber County Sheriff asks you to lock up your property. Lock your car at all times. Lock your doors. Lock your garage. Bring in your mail and packages after delivery.
- ▶ **Roads.** Winter is harsh on roads. Pot holes are being filled this spring. Drive safely.
- ▶ **Parks.** City parks open on April 15.
