## **City Government**

Marriott-Slaterville City consists of two (2) separate but equal branches. The Mayor leads the Executive Branch. The Legislative Branch is governed by the City Council. The Executive Branch manages the daily operations of the City such as: municipal services, complaints, roads, parks, planning, pressurized irrigation, and other services. The Legislative Branch approves: the budgets, ordinances, resolutions, contracts, appointments, and manages oversight. Two (2) members of the City Council are elected from the East District, and two (2) are elected from the West District. One (1) council member is elected Atlarge. There is a total of five (5) members of the City Council. City elections are held during odd numbered years. For questions call the City Office at 801-627-1919.

## Local Updates

- ► Garbage Rates. Garbage rates will increase to cover the cost of inflation. The new monthly rates will be \$22 first can, \$12 second can, and \$8 recycling can.
- Dark Sky. The City adopted a Dark Sky Ordinance in 2017. Light pollution affects sleep patterns and health. Please turn off your lights. Replace lights that are not compliant. If you have questions refer to the International DarkSky Association: darksky.org.
- Nuisances. Performance standards are regulations that limit nuisance activities such as loud noises, vibrations, and construction during hours when people are sleeping. Please be a courteous neighbor or business and limit disturbances at night or early morning.
- Dog. Please walk dogs using a leash and keep your dog from excessively barking. Too many neighbors are experiencing aggressive dogs while walking in the community.
- Ride Safe. It is legal to use an OHV only on local roads for operators who have a valid license, insurance, and registration. OHVs are still prohibited on state roads, parks, and trails. State law now requires OHV operators to complete the Utah Off-Highway Vehicle Education Course.
